(4) Legal basis for data processing

(6) Third country transmission?

(7) Duration of data storage

(8) You have the following rights:

- According to Art. 15 GDPR, you may request information about your personal data processed by the person responsible (e.g. on the processing purposes, the categories of personal data, the categories of recipients, the planned retention period).
- According to Art. 16 GDPR, you can immediately request the correction of incorrect or completion of your personal data stored by the person responsible.
- According to Art. 17 GDPR, under certain circumstances you may request the deletion of your personal data stored by the person responsible.

- According to Art. 18 GDPR, you may, under certain conditions, request the restriction of the processing of your personal data.
- According to Art. 20 GDPR, you may receive your personal data that you have provided to the person responsible in a structured, standard and machine-readable format or request the transmission to another person responsible.
- According to Art. 7 (3) GDPR, you can revoke your once given consent at any time to the person responsible. As a result, the person responsible may not continue the data processing, which was based solely on this consent, for the future.
- According to Art. 77 GDPR you can complain to a supervisory authority. As a rule, you can contact the supervisory authority of your usual place of residence or work or our company headquarters.
